



## ERC Congress - Resuscitation 2024

### TERMS & CONDITIONS

#### Organisation of the European Resuscitation Council (ERC) Congress – Resuscitation 2024.

The European Resuscitation Council (ERC) will host its “Resuscitation 2024” congress on the 31<sup>st</sup> October – 2<sup>nd</sup> November 2024 in Athens, Greece (the “congress”). On registering for the congress, participants (also referred to as “you”) are entering an agreement with the ERC. By registering to the congress, you are indicating your acceptance of the terms and conditions set out below.

#### 1. Congress Registration

- a. All participants are requested to register in advance by completing and submitting the online registration form with the appropriate fee.
- b. All participants must register for the congress via the congress website (<https://www.resuscitation.eu/registration>) or through CoSy (ERC e-learning system). Registration by email is not possible.
- c. Registration validity will be confirmed upon payment receipt by the ERC.

Please, note that to register to the congress, participants are required to create a free account in CoSy first. If you already have an account in CoSy, you can immediately proceed to the congress registration.

- d. Registration fee for participants includes:
  - Access to the congress venue and all available congress rooms.
  - Admission to all congress sessions.
  - Coffee breaks and lunches as specified in the congress programme.
- e. Registration confirmation email will be sent to participant’s email address upon receipt of registration fee payment by the ERC.

## 2. Payment

- a. Payments can be made via wire transfer or credit card.
- b. On-site cash payments will not be permitted. Only payments by credit card will be possible.
- c. All participants registering after September 15, 2024 are requested to make all payments by credit card exclusively. Payments via bank transfer will not be possible anymore.
- d. All fees for the congress registration should be paid in Euro (EUR), free of all banking charges – clearly stating the payment reference of the order.

**IMPORTANT: in case the ERC does not receive the registration fee payment within the 30 days from the date of congress registration, such registration will automatically be cancelled.**

## 3. Cancellation / Refund Policy

- a. All registration cancellation requests should be sent in writing to [congress@erc.edu](mailto:congress@erc.edu)
- b. The following cancellation fees will apply:
  - Cancellations received up to 1<sup>st</sup> August'24: full refund minus administrative fee of 50€.
  - Cancellations received as of 2<sup>nd</sup> August: no refund possible.
  - Social Event cancellations received after 2<sup>nd</sup> August: no refund possible.
  - Registration replacement / change of name requests should be sent in writing to [congress@erc.edu](mailto:congress@erc.edu) and a fee of 50€ (EUR) plus the difference in a registration fee (if any) will be charged. Registration replacement/change of name requests must be submitted before the 15<sup>th</sup> of October 2024. Requests submitted as of the 16<sup>th</sup> of October and onsite requests will not be accepted.
  - Change of billing address/adding own references requests should be sent in writing to [congress@erc.edu](mailto:congress@erc.edu) before the 15<sup>th</sup> of October 2024 and a fee of 50€ (EUR) will be charged. As of the 16<sup>th</sup> of October 2024 any changes in billing address/adding own references will no longer be possible.

**IMPORTANT: If your organization will pay for or reimburse your attendance at the congress/social event, please obtain the accurate billing information from your organization before proceeding with the registration.**

All refunds are subject to prevailing exchange rates. **Refunds will be made after the congress** in the same manner and to the same account as the original payment was received. If bank charges apply, they will be deducted from the refunded amount.

## 4. Data Privacy and Security

The European General Data Protection Regulation (EU GDPR) entered into force as of 25 May 2018 and it involves some additions to data protection. ERC takes your privacy very seriously and performs its activities and services in compliance with GDPR requirements.

## **5. Intellectual Property**

- a. You agree not to reproduce, copy, or translate the congress materials presented at the venue or via the congress App or create derivative works from them or modify them or in any way commercially exploit them without our prior written consent.
- b. All intellectual rights pertaining to the congress App, its software, design, contents (text, pictures, videos and other material), news, updates, notifications as well as all email notifications sent by it are ruled by ERC's Copyrights notice. ERC's Copyrights notice forms part of these Terms. By using the congress App, users indicate that they accept and comply with it.

## **6. Use of Materials**

The ERC may arrange for screenshots, photos, video and voice recordings to be taken during the congress.

- a. Any subsequent screenshots, photos, video and voice recordings will remain the property of the ERC and may be used for promotional purposes. By registering to the congress, you waive any right to compensation or remuneration for the use of such screenshots, photos, video and voice recordings.
- b. Other third parties (including exhibitors) may also arrange for screenshots, photos, video and voice recordings to be taken during the event.
- c. Your name and function may be shown to the ERC, other visitors and exhibitors.
- d. By submitting this registration form you are agreeing to the recording of the proceedings.

## **7. Disclaimer and "force majeure"**

- a. The participant acknowledges that he/she has no right to lodge damage claims against the ERC should the holding of the congress be hindered or prevented by unexpected political or economic events or generally by "force majeure" or should the non-appearance of speakers or other reasons necessitate program changes.
- b. Force majeure reasons include but are not limited to: war or threat of war, riots, civil strife, terrorist activity, industrial disputes, natural or nuclear disaster, adverse weather conditions, epidemics, pandemics, health risks, fire and closure of airports or airspace.
- c. By registering to the congress the participant accepts this proviso.

## **8. Rules of Conduct**

The ERC is committed to enabling events at which everyone can participate in an inclusive, respectful, and safe environment. We value each member and want all guests to have an enjoyable and fulfilling experience. Accordingly, we expect all participants to show respect and courtesy to other people. All communication should be appropriate for a professional

audience, including people of different backgrounds. Congress participants are solely responsible for their actions.

All contents submitted to the ERC or shared on the congress App shall adhere to basic rules of conduct. An appropriate tone and relevance of the content are required. It is in particular prohibited to submit content which:

- is openly offensive and fosters or incites racism, bigotry, hatred or physical violence of any kind against groups or individuals or force of any kind against property;
- is offensive, threatening, obscene, disrespectful, indecent, defamatory or libelous or causes harassment in another way or supports such undesirable forms of behavior;
- encourages sexual or violent exploitation of persons;
- comprises nudity, violence or indecent images;
- publishes information which poses a risk to the protection of personal data or security;
- contains or endorses information which, to the best of the participant's knowledge, is false or misleading;
- infringes intangible property rights (to trademarks, designs, patents or copyright), especially which constitutes or promotes illegal or unauthorized copies of copyright works of other persons, e.g. pirated copies of computer programs or links to them, information on defeating copy protection set up by manufacturers and pirated copies of music or links to pirated copies of music files;
- entails sending junk mails, chain letters or unsolicited mass mailings, SMS, spinning or spamming;
- has restricted, password-only access or contains hidden pages or images;
- promotes or supports unlawful acts or plans or contains instructions on illegal acts, e.g. making or buying illegal weapons, breach of privacy or the supply or development of computer viruses;
- requires other users to disclose passwords or personal particulars for commercial or illegal purposes, or is designed to do so;
- contains commercial activities;
- contains photographs or videos of other people, which have been published without the consent of those people;
- infringes, or attempts to infringe, in particular privacy laws, contract law or the rights of third parties;
- contains website links which are prohibited under this article.

Breaches of these Rules of Conduct may result in disqualification from participating in the registered congress, but also future live and virtual events.

## **9. Governing Law**

Any dispute resulting from the above terms and conditions will be subject to Belgian law, and by accepting these terms you are submitting yourself to the exclusive jurisdiction of the courts of Belgium.

Should any provision of these terms and conditions, including the applicable Copyrights notice and Privacy Policy, be considered unworkable, this shall not affect the validity of all or any other provisions. Failure by the ERC to implement a provision shall imply no waiver thereof.
